

## Official Rules: Bank of Canton's 'TIS THE SEASON Drawing

**How to Enter:** There are two methods by which participants may enter the Drawing: 1.) automatic entry, whereby participants make a minimum of 15 purchase transactions during the Drawing Period ("Eligible Transactions") with an eligible Bank of Canton Debit Card ("Eligible Card") and are awarded one entry per Eligible Transaction, and/or 2.)
